Proxy Voting – Guidelines and Conditions

1. THIS PROXY AND VOTING FORM ("PROXY FORM") IS SOLICITED BY THE BOARD OF DIRECTORS OF THE CORPORATION.
2. THIS PROXY FORM SHOULD BE READ IN CONJUNCTION WITH THE MEETING MATERIALS PRIOR TO VOTING.
3. If you appoint the Chair of the Meeting to vote on your behalf, the Chair of the Meeting will vote in accordance with your instructions or, if no instructions are given, in accordance with the Voting Recommendation highlighted for the Scheme Resolution on the reverse. If you appoint someone else to vote your securities, they will also vote in accordance with your instructions or, if no instructions are given, as they in their discretion choose.
4. This proxy form confers discretionary authority on the person named to vote in his or her discretion with respect to amendments or variations to the matters identified in the Notice of Scheme Meeting to which this proxy form relates or such other matters which may properly come before the Meeting or any adjournment or postponement thereof.
5. Each holder has the right to appoint a person other than the Chair of the Meeting to represent them at the Meeting or any adjournment or postponement thereof. Such right may be exercised by inserting in the space labeled "Please print appointee name", the name of the person to be appointed, who need not be a security holder of the Corporation.
6. Each holder is entitled to appoint up to two persons as proxies to attend the Meeting and vote on a poll. If you wish to appoint a second proxy, an additional proxy form may be obtained by contacting TSX Trust Company or you may copy this proxy form and return both proxy forms together.
To appoint a second proxy you must:
 - (a) on each of the first proxy form and the second proxy form state the percentage of your voting rights or number of securities applicable to that proxy form. If the appointments do not specify the percentage or number of votes that each proxy may exercise, each proxy may exercise half your votes. Fractions of votes will be disregarded; and
 - (b) return both proxy forms together.
7. To be valid, this proxy form must be signed. Please date the proxy form. If the proxy form is not dated, it is deemed to bear the date of its receipt by TSX Trust Company.
8. To be valid, this proxy form must be filed using one of the **Voting Methods** and *must be received by TSX Trust Company* by 7:30pm (Eastern Time) on October 10, 2023. Late proxies may be accepted or rejected by the Chair of the Meeting in his discretion, and the Chair of the Meeting is under no obligation to accept or reject any particular late proxy.
9. If the holder is a corporation, the proxy form must be executed by an officer or attorney thereof duly authorized, and the holder may be required to provide documentation evidencing the signatory's power to sign the proxy form.
